



## Manufacturer's Warranty

Covers in Play (hereinafter referred to as CIP) warrants each new Auto Pool Reel manufactured by CIP, when installed for and under normal residential use to be free from defects in material and workmanship as set forth below. This limited warranty is valid only to the original purchaser of the product when paid for in full. This warranty is not assignable or transferable to any subsequent purchaser or user and applies only when the product is purchased through a CIP authorized dealer or distributor and is used within the United States of America or Canada.

CIP will, at its option, repair or replace free of charge any part which, upon examination, inspection and testing by CIP or a CIP Authorized Distributor, is found to be defective. Shipping & handling charges on product submitted for repair or replacement under this warranty must be borne by the purchaser. Any equipment or component that the purchaser claims to be defective must be examined by the nearest CIP Authorized Distributor. This warranty covers the following system components for the associated warranty periods as listed below.

Auto Pool Reel	1 year
Thermal or Solar Blanket	2 years

This warranty shall come into effect for the items and periods set forth above upon the registration of the site specific warranty registration form provided. The Product Warranty registration form must be submitted to CIP within fifteen (15) days of purchase. The warranty period will commence from the date of purchase as indicated on your paid receipt.

All warranty claims must be submitted as set forth within this document.

If you suspect or notice manufacturing defect(s) in your Auto Pool Reel, please notify CIP in writing (written notification) of the claimed defect(s) within thirty (30) days of discovery of said defect(s), at the following address:

This written notification must include a description of the defect(s), the address of the installed Auto Pool Reel, plus a copy of the paid receipt. Any repairs or attempted repairs made before CIP inspection and/or authorization may void the terms of this warranty.

If after inspection by CIP, it is determined that said defect(s) is covered by this warranty, CIP shall within fifteen days (15) days deliver to you refinished, repaired or new components to remedy the defect.

CIP reserves the right to discontinue and make changes to any of its components. In the event that components covered by this warranty are not available, CIP shall have the right to substitute.

The Warranty Registration Form below must be completed and mailed within fifteen days (15) days of purchase to register and validate this warranty.
